# Data Management Data Backbone Services Requirements

The LSST DM System needs to maintain a set of data storage resources distributed between the Base Center and NCSA to hold the record of the survey and to be used by Prompt Products, Data Release Products, and Data Access Center (DAC) services. The Data Backbone (DBB) is the component that will provide storage, management, and replication for all LSST data products.

The scope of the Data Backbone includes both files and data maintained by relational and other database engines. While the Data Backbone provides read-only data service to the US and Chilean DACs, it will not host data stores where DAC users create state. For example, DAC resources such as Qserv and User Database Workspaces are provisioned in the context of a DAC, not the Data Backbone.

This document presents requirements for the Data Backbone. Currently these initial requirements are derived directly from LSE-61 requirements. The requirements will increase in number and detail as requirements flow down from the other components/services that use the Data Backbone.

## 1 Core Requirements

### 1.1 Pipeline Availability

**ID:** DMS-DBB-REQ-0001

**Specification:** Except in cases of major disaster, the Data Backbone shall not have an unscheduled outage which in turn causes an unscheduled outage of any active DMS production pipelines extending over a period greater than **productionMaxDowntime**.

## 1.2 Raw Science Image Metadata

**ID:** DMS-DBB-REQ-0002

**Specification:** For each raw science image, the Data Backbone shall store image metadata including at least the information detailed in DMS-REQ-0068

## 1.3 Difference Exposure Attributes

**ID:** DMS-DBB-REQ-0003

**Specification:** For each Difference Exposure, the Data Backbone Services shall store at least the information detailed in DMS-REQ-0074

## 1.4 Maintain Archive Publicly Accessible

**ID:** DMS-DBB-REQ-0004

**Specification:** The Data Backbone Services shall maintain and preserve the catalog files for all releases in a publicly accessible state for the entire operational life of the LSST observatory.

**Discussion:** The scientific intent is satisfied by keeping data products from the current DRP release and the one prior available with low-latency, in a form readily queryable by the public. Earlier releases may be available from deep-store with potentially high latency, for bulk download by users. The queryable catalogs (i.e., loaded into a database) may only be in QServ in which case this is not part of the Data Backbone.

## 1.5 Solar System Objects Available Within Specified Time

**ID:** DMS-DBB-REQ-0005

**Specification:** The Data Backbone Services shall replicate tables containing detected moving objects and associated metadata to all endpoints to enable public access in the DMS science data archive within time **L1PublicT** of their generation by the DMS.

## 1.6 Keep Historical Alert Archive

**ID:** DMS-DBB-REQ-0006

**Specification:** The Data Backbone Services shall preserve and replicate in an accessible state an alert archive with all issued alerts for a historical record and for false alert analysis.

**Discussion:** Part of L1 Data Products which have availability requirements at both endpoints. May not be in consolidated database.

### 1.7 Public access to Engineering and Facility Database Archive data

**ID:** DMS-DBB-REQ-0007

**Specification:** The Data Backbone Services shall permanently archive and replicate the data provided by the EFD ETL Service to be available at both endpoints for public access within **L1PublicT** hours of their original generation by the OCS.

### 1.8 Level 3 Access to Metadata and Provenance

**ID:** DMS-DBB-REQ-0008

**Specification:** The Data Backbone Services shall store and make queryable metadata and provenance that allow Level 3 processing tasks ensure that they are getting self-consistent inputs from the Data Backbone.

**Discussion:** This requirement does not mean that the LSST Data Backbone is responsible

for saving the outputs of the Level 3 processing tasks nor the metadata and provenance for those outputs.

## 1.9 Maintaining and validating exported data

**ID:** DMS-DBB-REQ-0009

**Specification:** The Data Backbone shall facilitate Level 3 image processing that may take place at external facilities outside the DACs by facilitating the export of catalogs and the provision of tools for maintaining and validating exported data.

**Discussion:** Maintaining is doing things like checking to see whether anything has been accidentally removed from my exported collection and re-exporting it if it was. Checksums are sufficient for validating, although digital signatures would be better.

## 1.10 Federation with external catalogs

**ID:** DMS-DBB-REQ-0010

**Specification:** For project approved externally provided catalogs, the Data Backbone shall load and replicate the catalog for accessibility at all endpoints.

**Discussion:** The project will provide specification for how external data must be provided in order to make loading possible. These catalogs can be joined with other catalogs in the Data Backbone as well as LSP user catalogs that are loaded into their consolidated database quota.

## 1.11 Level 3 image processing facilitation

**ID:** DMS-DBB-REQ-0011

**Specification:** The Data Backbone shall facilitate Level 3 image processing that may take place at external facilities outside the DACs by facilitating the export of image datasets and the provision of tools for maintaining and validating exported data.

**Discussion:** Maintaining is doing things like checking to see whether anything has been accidentally removed from my exported collection and re-exporting it if it was. Checksums are sufficient for validating, although digital signatures would be better.

## 1.12 Calibration Data Products and Image Provenance

**ID:** DMS-DBB-REQ-0012

**Specification:** The Data Backbone Services shall archive and replicate calibration data products, specified in DMS-REQ-130, including metadata, provenance, and calibration database tables.

### 1.13 Daily Calibration Products Update Availability

**ID:** DMS-DBB-REQ-0013

**Specification:** The Data Backbone Services shall be capable of supporting daily calibration product updates to be generated from a group of **nCalExpProc** related exposures where outputs must be accessible from the Data Backbone Services within **calProcTime** of the end of the acquisition of images/data for that group

**Discussion:** calProcTime includes many things so the requirement needs to be broken down into its components to understand exact time requirements for the Data Backbone.

### 1.14 Optimization of Cost, Reliability and Availability in Order

**ID:** DMS-DBB-REQ-0014

**Specification:** Within a fixed cost envelope for the Data Backbone Services, the allocation of storage facilities will optimize reliability over availability to end users.

**Discussion:** Reliability of services needed for production over availability/access for end users. (Bursts of end user activity can mean temporary higher priority resources for end users.)

### 1.15 Pipeline Throughput

**ID:** DMS-DBB-REQ-0015

**Specification:** The Data Backbone Services shall be capable of supporting the data processing pipelines in completing processing of a night’s observing data prior to the start of the next observing night, assuming no system outages

**Discussion:** While the crosstalked raw files will not be retrieved from the Data Backbone, templates and master calibrations that are used in the Alert Processing are loaded from the DBB

### 1.16 Re-processing Capacity

**ID:** DMS-DBB-REQ-0016

**Specification:** The Data Backbone Services shall be capable of supporting the execution of the DMS Data Release Production over all pre-existing survey data in a time no greater than **drProcessingPeriod**, without impacting observatory operations.

### 1.17 Temporary Storage for Communications Links

**ID:** DMS-DBB-REQ-0017

**Specification:** The infrastructure for the Data Backbone Services will provide for temporary storage for a minimum of **tempStorageRelMTTR** of the mean time to repair of any communications network link at or before the source end of that link.

**Discussion:** Most of the storage in the Data Backbone Services is actually permanent storage. This requirement does cover any internal temporary storage used by the Data Backbone Services. This requirement does not cover any temporary storage used by other services for data prior to ingesting into the Data Backbone Services.

### 1.18 Infrastructure Sizing for “catching up”

**ID:** DMS-DBB-REQ-0018

**Specification:** The infrastructure for the Data Backbone Services will be sized such that after outages, “catch up” processing of the temporarily stored raw image data may occur at the rate of one night’s observing data processed per day, without interrupting the current day’s observatory operations.

## 1.19 Fault Tolerance Features

**ID:** DMS-DBB-REQ-0019

**Specification:** The Data Backbone Services will incorporate infrastructure with fault-tolerance features to prevent loss of data in the event of hardware or software failure.

## 1.20 Incorporate Autonomics

**ID:** DMS-DBB-REQ-0020

**Specification:** The infrastructure for the Data Backbone Services will incorporate sufficient capability for self-diagnostics and recovery to provide for continuation of processing in the event of partial hardware or software failures.

## 1.21 Base Facility Infrastructure

**ID:** DMS-DBB-REQ-0021

**Specification:** The infrastructure of the Data Backbone Services at the Base Facility shall be sufficient to store a copy of designated data from the Archive Facility data holdings, and to provide the access capabilities to support Commissioning activities and the Chilean DAC.

**Discussion:** TBD: Determine details to guide infrastructure sizing such as number of DB connections, number of simultaneous file downloads, transfer throughput, This requirement does not include raw ingestion as still no requirements yet for whether raw files must be accessible at Base via DBB while NCSA endpoint is unavailable to initiate the ingestion.

## 1.22 Archive Center

**ID:** DMS-DBB-REQ-0022

**Specification:** The infrastructure of the Data Backbone Services at the Archive Center shall support, simultaneously: nightly processing including image processing, detection, association, and moving object pipelines, and the generation of all time-critical data products, i.e. alerts; the data release production, including Level-2 data product creation, permanent storage for all data products (with provenance), including federated Level-3 products; and serve data for replication to data centers and end user sites.

## 1.23 Archive Center Disaster Recovery

**ID:** DMS-DBB-REQ-0023

**Specification:** The Data Backbone Services shall provide disaster recovery support preventing loss of LSST data in the case of infrastructure or facility-threatening events. This support shall enable recovery of all LSST archived data from backed up sources, including project Data Access Centers.

## 1.24 No Limit on Data Backbone Endpoints

**ID:** DMS-DBB-REQ-0024

**Specification:** The number of Data Backbone endpoints shall be limited only by available internal or external funding. No architectural constraints will be placed on the Data Backbone Services that prohibit the addition of Data Backbone endpoints at any time, subject to funding.

## 1.25 Exposure Catalog

**ID:** DMS-DBB-REQ-0025

**Specification:** The Data Backbone Services shall store an Exposure Catalog containing information for each exposure that includes information detailed in DMS-REQ-0266.

**Discussion:** This requirement includes the catalog file itself as well as the contents in a queryable table following lifecycle policies.

## 1.26 Catalog

**ID:** DMS-DBB-REQ-0026

**Specification:** The Data Backbone Services shall store a catalog of all Sources detected on Difference Exposures with  $\text{SNR} > \text{transSNR}$ . For each Difference Source (DIASource), the catalog will include information detailed in DMS-REQ-0269.

**Discussion:** This requirement includes the catalog file itself as well as the contents in a queryable table following lifecycle policies for the DIASource catalogs from the Alert Processing. The contents of the DIASource catalogs from Data Release Processing instead go into Qserv.

## 1.27 DIAObject Catalog

**ID:** DMS-DBB-REQ-0027

**Specification:** The Data Backbone Services shall store a catalog of all astrophysical objects identified through difference image analysis (DIAObjects). The DIAObject entries shall include metadata attributes including at least those detailed in DMS-REQ-0271.

**Discussion:** This requirement includes the catalog file itself as well as the contents in a queryable table following lifecycle policies for the DIAObject catalogs from the Alert Processing. The contents of the DIAObject catalogs from Data Release Processing instead go into Qserv.

## 1.28 SObject Catalog

**ID:** DMS-DBB-REQ-0028

**Specification:** The Data Backbone Services shall store a catalog of all Solar System Objects (SObjects) that have been identified via Moving Object Processing. The SObject catalog shall include for each entry attributes including at least those detailed in DMS-REQ-0273.

**Discussion:** This requirement includes the catalog file itself as well as the contents in a queryable table following lifecycle policies.

## 1.29 DIASource Precovery

**ID:** DMS-DBB-REQ-0029

**Specification:** For all DIASources not associated with either DIAObjects or SObjects, the Data Backbone Services shall support the calculation of forced photometry at the location of the new source (precovery) on all Difference Exposures obtained in the prior **precoveryWindow**, and make the results publicly available within **L1PublicT**.

### 1.30 Query Repeatability

**ID:** DMS-DBB-REQ-0030

**Specification:** The Data Backbone Services shall ensure that the data is available such that any query executed at a particular point in time against any Data Backbone delivered database shall be repeatable at a later date, and produce results that are either identical or include additional results (owing to updates from Level-1 processing).

**Discussion:** Schemas may change as long as the front-end services adapt old queries to the new schema. The "delivered database" is not the "ForcedSource Catalog" for all time; it's the "ForcedSource Catalog for DR5" or the "ForcedSource Catalog for DR6" etc.

### 1.31 Uniqueness of IDs Across Data Releases

**ID:** DMS-DBB-REQ-0031

**Specification:** To reduce the likelihood for confusion, all IDs shall be unique across databases and database versions, other than those corresponding to uniquely identifiable entities (i.e., IDs of exposures).

**Discussion:** For example, DR4 and DR5 (or any other) release will share no identical Object, Source, DIAObject or DIASource IDs. However, IDs shall be identical for the same data across Data Backbone endpoints.

## 1.32 Selection of Datasets

**ID:** DMS-DBB-REQ-0032

**Specification:** A Dataset may consist of one or more pixel images, a set of records in a file or database, or any other grouping of data that are processed or produced as a logical unit. The Data Backbone Services shall store and replicate data needed to be able to identify data in the Data Backbone and retrieve complete, consistent datasets from the Data Backbone for processing.

## 1.33 Processing of Datasets

**ID:** DMS-DBB-REQ-0033

**Specification:** The Data Backbone Services shall support codes that process all requested datasets until either a successful result is recorded or a permanent failure is recognized. If the results of any dataset is processed, in part or in whole, more than once and stored in the Data Backbone, the Data Backbone Services will support the labeling such that only one of the wholly processed results will be found for further processing.

**Discussion:** The requirement is limited to within a single processing campaign. It is not just about what gets released but also about what gets used in subsequent processing.

### 1.34 Data Product Ingest

**ID:** DMS-DBB-REQ-0034

**Specification:** The Data Backbone Services shall provide software for designated staff or processes to ingest designated data products into the Data Backbone.

### 1.35 Raw Data Archiving Reliability

**ID:** DMS-DBB-REQ-0035

**Specification:** The Data Backbone Services shall archive all data, including science, wave-front, and guider images and associated metadata, that are presented for archiving by upstream systems, with a rate of permanent data loss or corruption not to exceed **dataLossMax**.

**Discussion:** Data obtained for diagnostic and other limited-use engineering purposes are specifically excluded from this requirement.

### 1.36 Un-Archived Data Product Cache

**ID:** DMS-DBB-REQ-0036

**Specification:** The Data Backbone Services shall provide low-latency storage for un-archived Level 1 data products of at least **l1CacheLifetime** to enable efficient precovery and other Level-1 production measurements.

**Discussion:** Data must be available at both endpoints.

### 1.37 Level 1 Data Product Access

**ID:** DMS-DBB-REQ-0037

**Specification:** The Data Backbone shall store and replicate a Level 1 Database for query by science users, updated as a result of Alert Production processing.

### 1.38 Level 1 and 2 Catalog Access

**ID:** DMS-DBB-REQ-0038

**Specification:** The Data Backbone Services shall store and replicate designated catalogs from the most recent two Data Releases for query by science users, as well as versions of the most recent catalogs generated from Special Programs data.

**Discussion:** There is no requirement for older data releases to be queryable.

Some catalogs from the Data Releases may be only be stored in QServ (which is not in the Data Backbone)

### 1.39 Compute Platform Heterogeneity

**ID:** DMS-DBB-REQ-0039

**Specification:** At any given LSST facility the Data Backbone Services shall be capable of operations on a heterogeneous cluster of machines. The hardware, operating system, and other machine parameters shall be limited to a project-approved set.

**Discussion:** The necessity of replacing hardware throughout the course of the survey essentially guarantees heterogeneity within a cluster.

### 1.40 DIAForcedSource Catalog

**ID:** DMS-DBB-REQ-0040

**Specification:** The Data Backbone Serves shall store a DIAForcedSource Catalog which in-

cludes at least information detailed in DMS-REQ-0317.

**Discussion:** This requirement includes the catalog file itself as well as the contents in a queryable table following lifecycle policies for the DIAForcedSource catalogs from the Alert Processing. The contents of the DIAForcedSource catalogs from Data Release Processing instead go into Qserv.

### 1.41 Unscheduled Downtime

**ID:** DMS-DBB-REQ-0041

**Specification:** The Data Backbone Services shall be designed to facilitate unplanned repair activities that directly prevent the collection of survey data expected not to exceed **DMDown-time** days per year.

**Discussion:** The reference case would be a failure of communication or archiving that lasted longer than the capacity of the Summit buffer – i.e., an 11-day outage would exceed the nominal buffer capacity by one day and therefore use up the proposed allocation.

This requirement does not invoke the need to verify by reliability analysis. Verification is by analysis that identifies likely hardware failures and identifies mitigations to minimize downtime caused by those failures.

## 1.42 Special Programs Database

**ID:** DMS-DBB-REQ-0042

**Discussion:** This requirement covers subsets of data already in databases in the Data Backbone. It does not mean that data only loaded in Qserv will now be copied back to the Data Backbone’s databases.

That is, the system must be scalable to handle full-performance service of all Data Releases, should the operations project so choose. This situation does not arise until, at the release of Data Release (**nDRMin+1**), the operations project must decide on the level of service to be provided for Data Release 1.
